**(A) RESIGNATION OF THE NON-EXECUTIVE NON-INDEPENDENT DIRECTOR OF THE COMPANY**

Mr Chen Johnson (“**Mr Chen**”), the founder of the Company, has tendered his resignation as the Non-Executive Non-Independent Director of the Company, with his effective cessation date being 1 February 2023.

Consequently, Mr Chen will cease to be a member of the nominating committee (“**NC**”) of the Company with effect from 1 February 2023.
